#### 1 Introduction

NXP provides optional accessory boards that can be used to evaluate the i.MX 8M Plus EVK. The IMX-OS08A20 for the i.MX 8M Plus EVK is a MIPI-CSI interface camera kit based on OmniVision chipset OS08A20. The IMX-OS08A20 camera module can be purchased from 4K MIPI CMOS Camera Module product page.

This document provides a brief overview on how to get started with the IMX-OS08A20 accessory card and the i.MX 8M Plus EVK.

Key specifications / features:

- Image sensor optical size of 1/2" with 8 megapixels (3840 x 2160)
- Supported output formats: 12-/10-bit RAW RGB
- Maximum image transfer rate:
  4K (3840 x 2160): 60 fps
  1080 p (1920 x 1080): 120 fps
  720p (1280 x 720): 180 fps
- Lens parameters:
  - 1/1.8" IMX334
  - Max image circle: 9 mm diameterEffective focal length: 7.84 mm
  - Fixed Iris
  - Minimum object distance: 0.5 m
  - Mount method: screw

Note: i.MX8MPlus can only support up to 3840 x 2160 at 30 fps.

## 2 Get to know the IMX-OS08A20 accessory card

IMX-OS08A20 accessory card contains a bridge card and a camera module. The camera module is connected to the bridge card through a connector that is assembled during the manufacturing phase.

## 3 How to use the IMX-OS08A20 accessory card

This section describes quick steps to get started with the IMX-OS08A20 accessory card.

Note: Before plugging in the cable, remove the plastic cover on the mini-SAS connectors.

## 3.1 Hardware setup

To enable IMX-OS08A20 camera module, follow the steps below:

- 1. Plug-in the mini-SAS cable into the mini-SAS connector on the IMX-OS08A20 accessory card.
- 2. Plug-in the other end of the mini-SAS cable into J12 on the i.MX 8M Plus EVK.

#### 3.2 Software setup: Linux

The default Board Support Package (BSP) supports the MIPI-CSI on J12. To enable the camera on J12, replace the original \*.dtb file with imx8mp-evk-os08a20.dtb file as follows.

```
U-Boot > setenv fdtfile imx8mp-evk-os08a20.dtb
U-Boot > saveenv
U-Boot > boot
```

#### The camera GStreamer commands are:

```
gst-launch-1.0 -v v4l2src device=/dev/video2 ! "video/x-raw,format=YUY2,width=1920,height=1080" ! queue ! waylandsink gst-launch-1.0 -v v4l2src device=/dev/video2 ! "video/x-raw,format=YUY2,width=3840,height=2160" ! queue ! waylandsink
```
