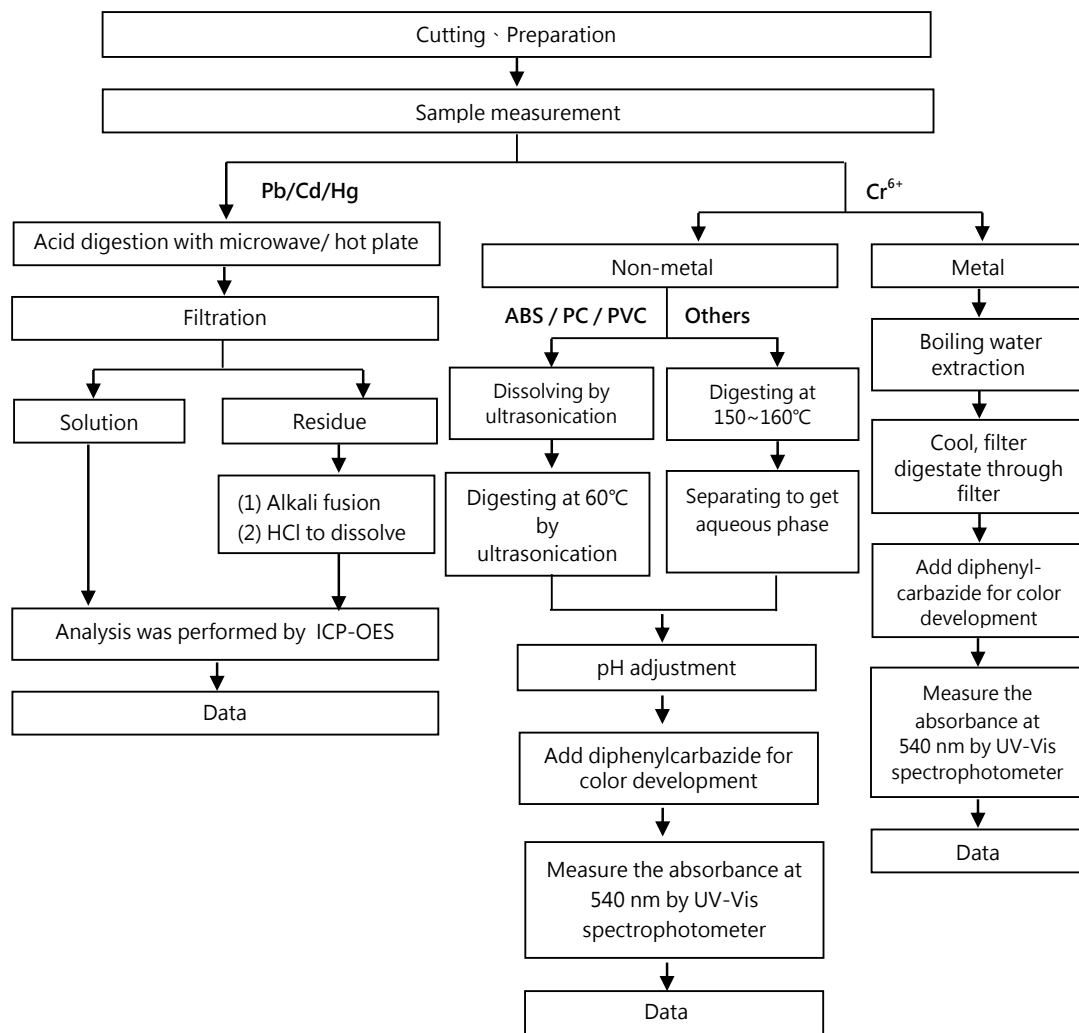

Analytical flow chart of heavy metal

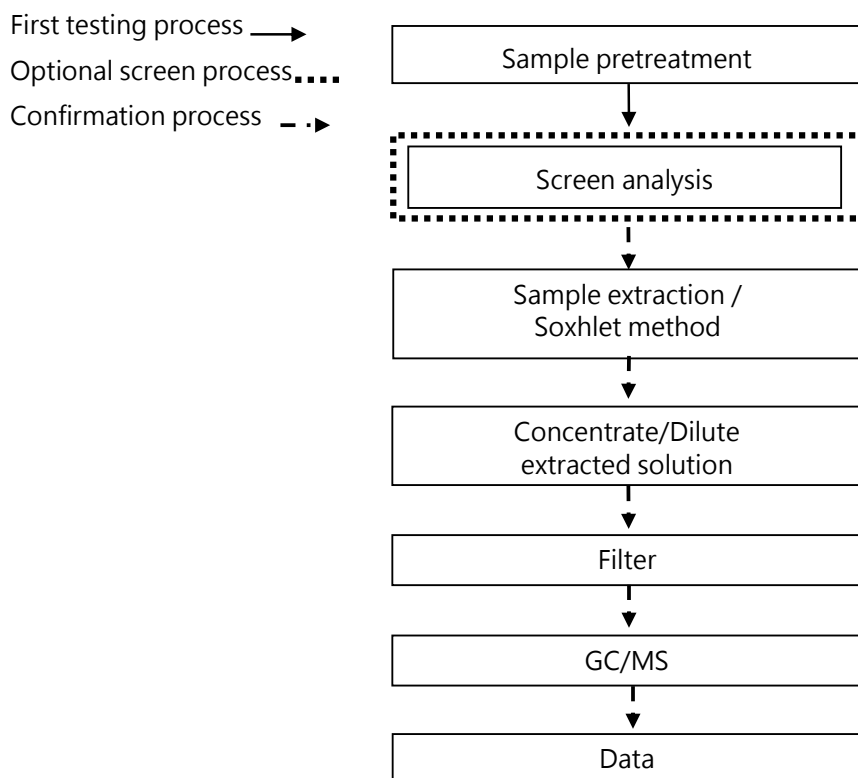

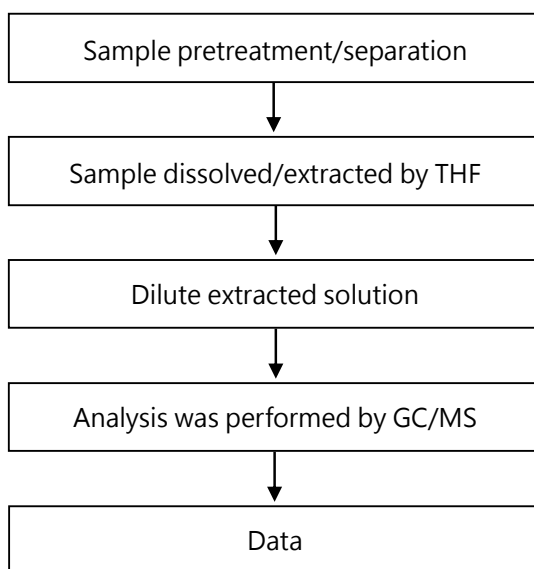
Analytical flow chart – PBBs / PBDEs

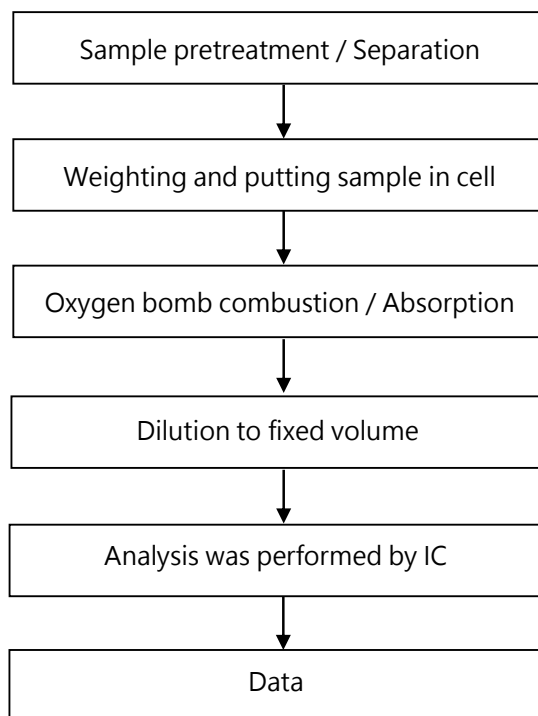
Analytical flow chart - Phthalate

Analytical flow chart - Halogen

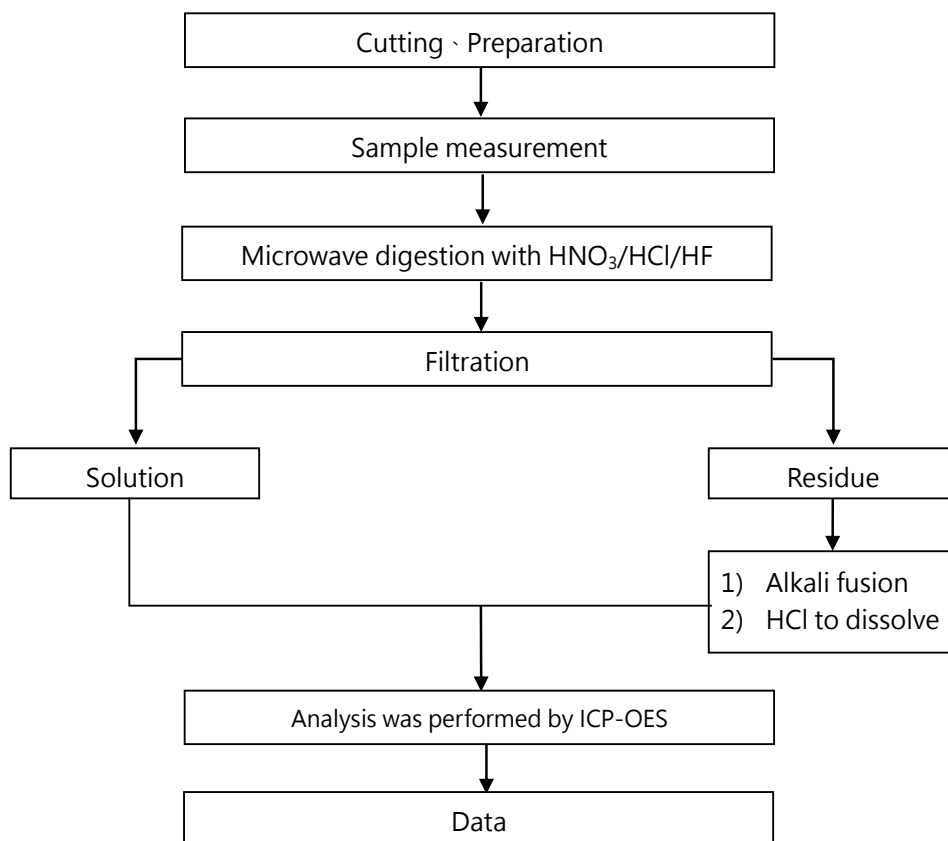
