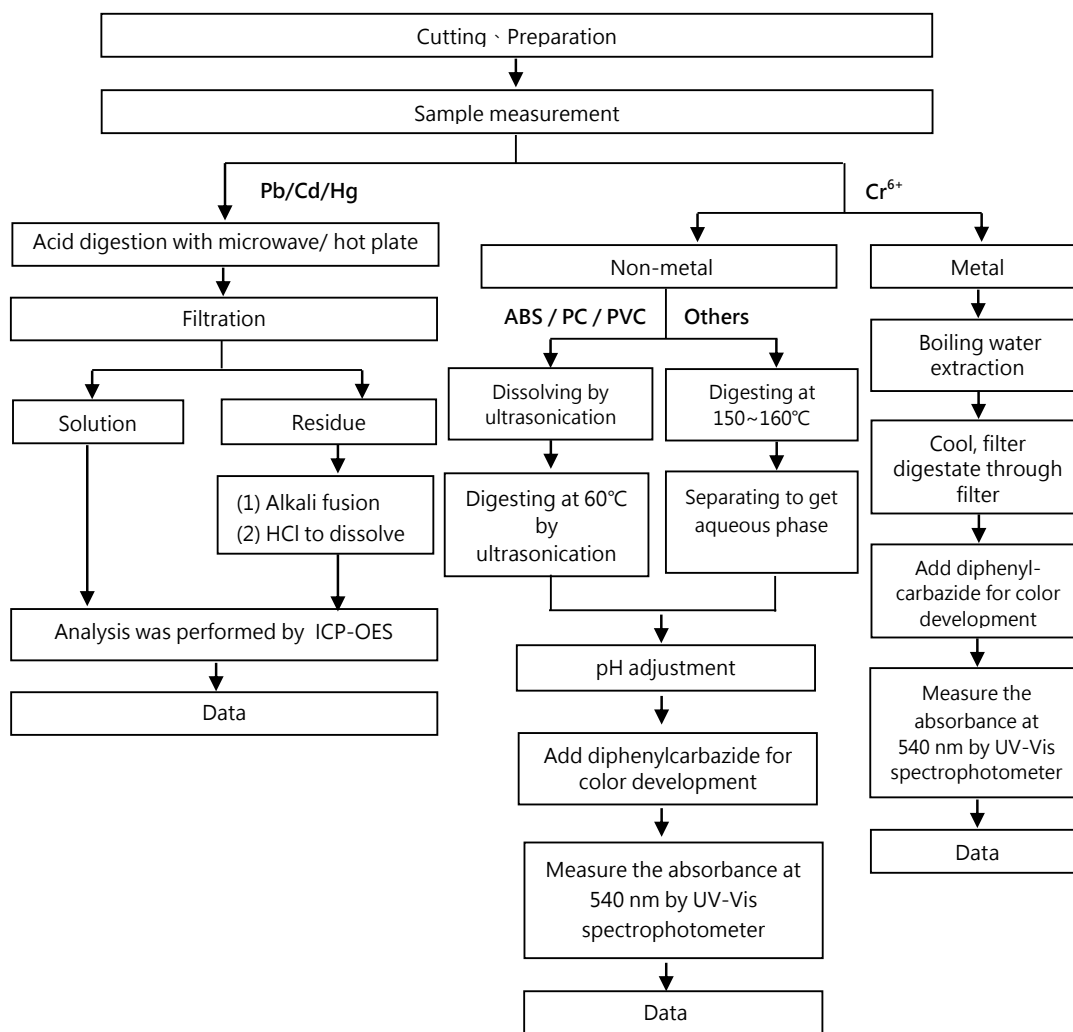

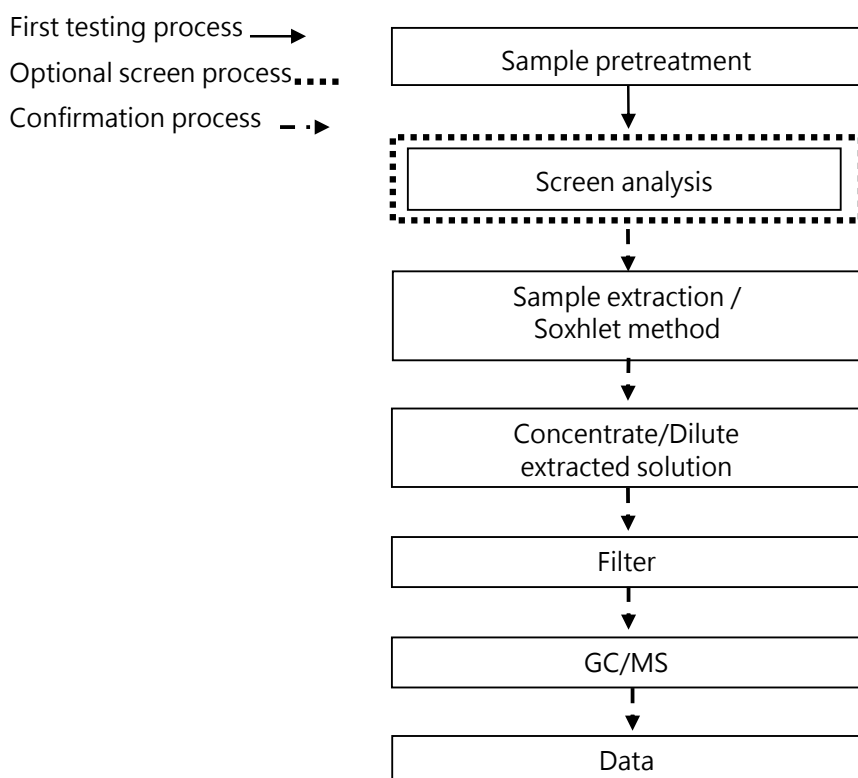
Analytical flow chart of heavy metal

(Cr⁶⁺ test method excluded)



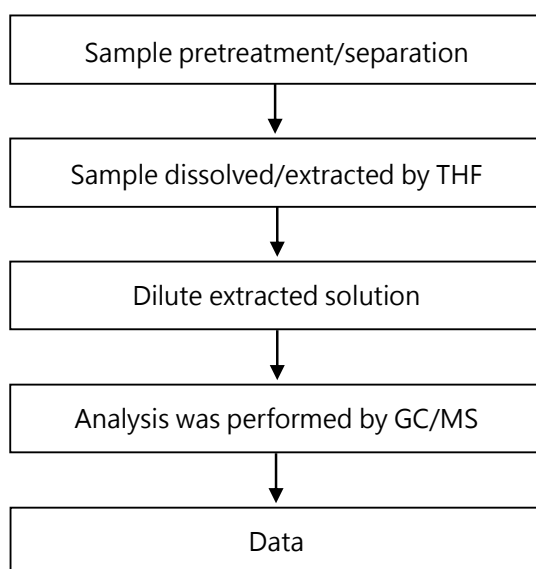
Analytical flow chart – PBBs / PBDEs

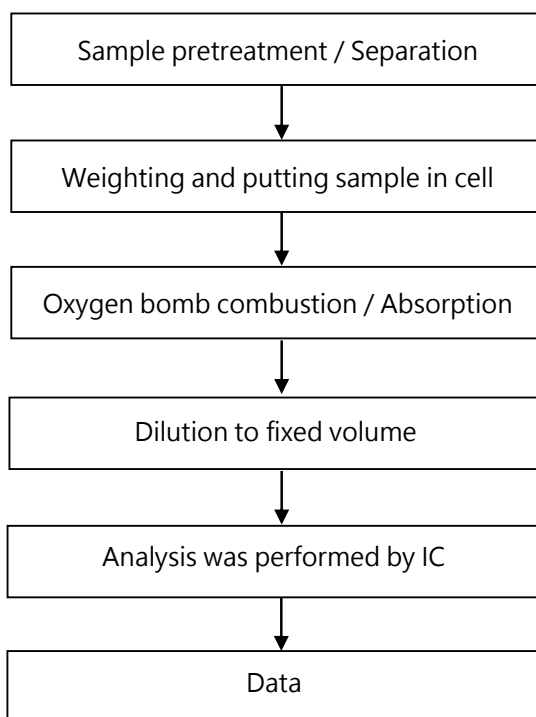
Analytical flow chart - Phthalate

Analytical flow chart - Halogen

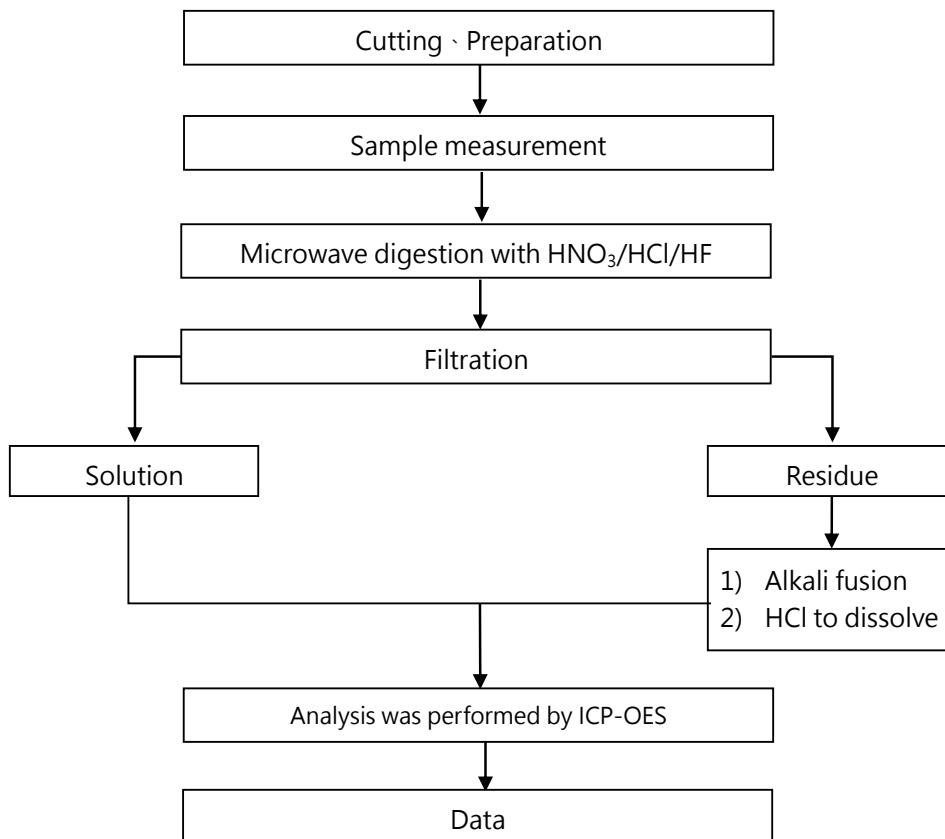
